- Fastest Growing Shire in the Northern Tablelands Electorate Growth Rate that exceeds many NSW Regional Centres. Population 16,846 Growth Rate Last 5 years of 0.624%.
- 2. Recognised Regional Service Centre for 69,000 people (Economic Impact Statement for Big W Development Application, prepared by independent consultants engaged by Woolworths Properties).
- 3. 1,678 Businesses in the Shire (Group 11 Council average 1,398).
- 4. Population per Councillor is 1,872 (Group 11 Council average is 1,495).
- 5. 212 Effective Full-time Staff, including Connections and Linking Together Centre.

EFFICIENCY

- 6. Real Operating Cost per Capita as shown in Council's Fit for the Future Roadmap, have decreased by 15% over the last 5 years and are estimated to drop by a total of 25% by the end of the 2016 2020 Fit for the Future period.
- 7. Governance and Administration costs 50% below the Group 11 Council Average and amongst the lowest in the Industry, resulting in more funds being available for Service and Infrastructure delivery.
- 8. Workers Compensation premiums of \$1.90 per \$100 of Wages Paid against an Industry Average of \$3.60 per \$100 of wages paid.
- 9. Work Health and Safety Performance of 99.2% (being 100% for WHS Management System Compliance and 98.4% for Specific Hazard identification and treatment). This is against an Industry average of 75%.
- 10. Achieved all Work Health and Safety and Public Liability Insurance Performance Rebates over the last 5 years saving Council over \$250K.
- 11. Energy Efficiency and Solar Energy cost savings now total \$365K p.a.
- 12. Savings of \$180K p.a. or \$1.8M over 10 years, in Light Plant Fleet Costs and a modern, efficient and technologically advanced Heavy Plant Fleet resulting in Council not having to increase its Plant Hire Charges in the last 6 years. This has significantly aided Council's ongoing Maintenance and Infrastructure Renewal Programs. GPS Tracking in process of being installed in Council's Plant Fleet to further improve efficiencies.
- Council's "return on investment" for programs delivered through the Linking Together Centre on behalf of the State and Federal Governments is up to \$6 return for every \$1 invested providing strong social gains to the community.

- 15. Typical Residential Sewer Bill of \$447.00 p.a. against a NSW Average of \$625.00 p.a. being 30% less.
- 16. Typical Residential Water Bill of \$548.00 p.a. with no water restrictions, against a NSW Average of \$550.00 p.a and a NSW Councils 3,000 to 10,000 properties Average of \$617.00, while providing significant ongoing water subsidies to Bindaree Beef (Inverell's largest employer and a business of State significance).
- 17. Lowest Waste Management Charges in the Region.
- 18. Recycling Rate is 45% against a Group 11 Council average of only 36%.

INFRASTRUCTURE

- 19. \$21M of renewed and new infrastructure delivered outside of Council's Road Infrastructure Programs over the last two Council Terms (7 years), with over 30% of these being funded from Grants.
- 20. New Ashford Water Treatment Plant \$4.6M, Cameron Park Redevelopment \$0.9M, Inverell Sewerage Treatment Plant Renewal and Upgrade \$3.6M and \$1.8M Gilgai Drainage Project being delivered. Grants and Local Infrastructure Renewal Scheme Interest Rate Subsidies secured for these projects.
- 21. 8 km of new Bike Paths and Footpaths over the last 7 years, with an additional \$440K of work programmed for 2015/2016 with \$ for \$ funding from NSW Roads and Maritime Services.

24. Bitumen Road Costs:

Reseal Costs are 25% below the IPWEA National Industry Benchmark. This result is efficiency driven and resulted in an additional 10km of roads being resealed in 2014/2015, (Total Reseal in 2014/2015 was 73.4km – basically equivalent of resealing from Inverell to Bingara).

Council's Annual Budget provides for approximately 57.14 km of Gravel Resheeting dependent on Road Type.

- 26. Remainder of Auburnvale Road to Copeton Northern Foreshores Bitumen Sealed \$400K in 2014/205 securing a \$200K Grant from NSW Roads and Maritime Services – Better Boating Grant Program. The 1 kilometre Bitumen Seal extension on Rifle Range Road was funded from Gravel Pit Royalty income from Myall Gravel Pit located on that Road.
- 27. \$6M in additional Regional and Rural Road Funding for 2015/2016 (including the \$1M Tintot Bridge Renewal) on top of the ongoing \$5M Regional and Rural Road Renewal/Construction and \$3.4M Rural Road Maintenance Programs.
- 28. Urban/Villages Renewal/Construction funding is \$0.5M, plus \$0.13M for Gilgai Drainage, and Urban/Villages Maintenance of \$1.56M in 2015/2016.
- 29. Modern Rural Fire Service and SES Plant Fleet and Infrastructure supporting the Shires RFS and SES Volunteers, and have donated 4 second-hand Bushfire Tankers to smaller Rural Shires.

GOVERNANCE

- 30. Council is one of the 67 NSW Council's who participate in the NSW Small Business Friendly Council Program.
- 31. Council is one of the 32% of NSW Council's that has an Audit and Risk Committee.
