Ted Ceely - Graman Resident

Mr Ceely addressed Council in regard to a recent event held at the Graman Recreation Reserve by the Sapphire City Motor Sports Club. Mr Ceely said the event created a dust hazard for residents and the organisers did not water the track sufficiently to prevent this. Mr Ceely was also concerned that the type of event was not within the bounds of permitted use as described in the agreement the Club has with Council and the development of a race track also contravened the agreement.

Pam McLeay - Inverell Sunrise CWA

Mrs McLeay sought Council assistance with an event to support adolescent boys. The proposed event follows the successful girl empowerment events run by the club in September 2018. The event is planned for May 2019 and would address issues such as mental health, body image, anger management and building effective and healthy relationships.

Stephen Lynn - Graman Resident

Mr Lynn also had concerns with the Sapphire City Motor Sports Club event recently held at Graman Sports Reserve. Mr Lynn had an issue with the noise and dust and felt the

MAYORAL MINUTE

I am calling on Councillors to support Local Government NSW in its advocacy to all those contesting the State election to reinvest 100% of the waste levy collected each year into waste management, recycling and resource recovery in NSW.

The Protection of the Environment Operations Act 1997 (POEO Act) requires certain licensed waste facilities in NSW to pay a contribution to the NSW Government for each tonne of waste received at the facility. Referred to as the 'waste levy', the contribution aims to reduce the amount of waste being landfilled and promote recycling and resource recovery.

The waste levy applies in the regulated area of NSW which comprises the Sydney metropolitan area, the Illawarra and Hunter regions, and the central and north coast local government areas to the Queensland border as well as the Blue Mountains, Wingecarribee and Wollondilly local government areas.

In 2016/17, the NSW Government collected \$726M from local government, community, businesses and industry via the waste levy, but only committed to use \$72M through its Waste Less Recycle More initiative – or 10% - on waste minimisation and recycling in 2017-18.

Overall the NSW Government's Waste Less Recycle More initiative allocates \$801M over 8 years (2013-2021) to waste and recycling, however the waste levy collected over that same period will be over \$4.62B.

Regardless of how you look at it, the principle remains the same – very little of the waste levy is currently used to support waste minimisation, recycling and resource recovery. The remainder is returned to NSW Government's consolidated revenue.

The reinvestment of the waste levy to support waste and resource recovery infrastructure, develop markets and innovative solutions, and undertake other initiatives to encourage reuse and recycling also offers wide-ranging benefits to our communities right across NSW. There is the potential for economic growth, new infrastructure, new technology and new jobs, particularly in our regional areas.

It should be noted that the following motion was unanimously endorsed at the Local Government NSW 2018 Conference:

That the NSW Government be called upon to ensure that 100% of the levy arising from Section 88 of the Protection of the Environment Operations Act 1997 be used for waste infrastructure and programs, predominantly by local government and the waste sector, for initiatives such as:

- Development of regional and region-specific solutions for sustainable waste management (e.g. soft plastic recycling facilities, green waste, waste to energy).
- Support innovative solutions to reduce waste and waste transport requirements.

- Protect existing and identify new waste management locations.
- Local community waste recovery and repair facilities.
- Funding a wider range of sustainability initiatives, such as marketing and strategies that promote and support a circular economy.

This motion covered motions proposed by Blacktown City Council (Resource recovery locations); Central Coast Council (Waste levy revenues); Cessnock City Council (Recycling crisis - funding support); City of Ryde (Revenue raised by the waste levy); Federation Council (Waste resource); Gwydir Shire Council (Tyre recycling); Hornsby Shire Council (Increase in grant funding for waste levy program); Leeton Shire Council (Increase of waste levy distribution); and Shoalhaven City Council (POEO Levies). Related motions were also submitted by Tweed Shire Council (Recycled products and procurement); Lake Macquarie Council (Support for recyclate end markets, reusable, recyclable or compostable packaging); and Orange City Council (Waste management).

As previously noted, this is not a party-political issue: the advocacy initiative calls on all parties and candidates to commit to the 100% hypothecation of the Waste Levy to the purpose for which it is collected.

I am recommending that we support this campaign by the NSW local government sector and Local Government NSW and call on all political parties to commit to the reinvestment of 100% of the Waste Levy collected each year by the NSW Government into waste management, recycling and resource recovery.

RELATIONSHIP TO STRATEGIC PLAN, DELIVERY PLAN AND OPERATIONAL PLAN:

SUBJECT:	BORDER REGIONAL ORGANISATION OF COUNCILS (BROC) DELEGATES REPORT – FEBRUARY 2019 AT INVERELL

SUMMARY:

Inverell hosted the first 2019 meeting of BROC and it was pleasing to see all but one of the member councils represented at the event. Cr Stewart Berryman also attended and it is always a benefit to have his wealth of knowledge contribute to the discussion.

COMMENTARY:

Bindaree Presentation

As hosting Council we organised the speakers and we invited Bindaree Beef to present. They provided a thought provoking report. Of all Council areas, most recent employment statistics for Inverell LGA show a growth in manufacturing employment. Also they show that this sector is by far the largest employer for our economy and considerably larger than other Councils making us highly susceptible to changes in this industry. Much of Mr McDonald's report has come from the Australian Meat Industry Council (AMIC) independent study and relates to difficulties of employment within the industry. For your information, I will include some of their statistics. Bindaree Beef Regional Economy Contribution 2018/19:

- Employs 800 team members
- Wage bill exceeding \$52M
- Payroll tax bill exceeding \$3M
- Livestock procurement costs (sourced within 400km radius of plant) \$300M
- Freight Bill exceeding \$10M
- Utilities Bill exceeding \$6m
- R & M expense exceeding \$3M

The 'cost to operate' componentry from competition from overseas suppliers is extreme. Average costs/head in domestic beef processing are 24% higher than in US, 100% higher than in Brazil and 75% higher than in Argentina. More than 54% of all costs incurred in Australia are from some form of regulation, twice that of the US & Argentina and three times that of Brazil. AMIC and Bindaree Beef are actively seeking long term policy change in these regulatory areas to ensure the sustainability of the industry and the viability of regional economies and their associated job markets.

It must be noted that our Council has already supported the lobbying for the abolition of payroll tax. Additionally, general discussion focused on the huge regulatory barriers for operational approval to expand. The group was very sympathetic to the issue having seen the effects of the closure of the Wallangarra Meatworks and the loss of 270 employees. However industries can change guickly and

the introduction of cluster fencing throughout all of southern QLD has turned this industry around and led to its resurgence.

RDANI – Russell Stewart

The Research & Development Institute is tackling the definition of what 'regional' means and its impact on our local regional economies and the attraction for skilled migration. Currently the term has a negative inference and they are actively working to change this perception for the benefit of attracting this cohort to our towns. When Wyalla Feedlot went through their expansion they needed their increased labour force to want to come to the regional hub of Texas and so worked to promote Texas as an attractive place to live for migrant workers. Interestingly, Balonne Shire has received grant funds to promote the decentralisation of employment to their region.

Joan White – Goondiwindi Regional Council & Lions Club Rural Minds Community Workshops

In response to the awful seasonal drought conditions, Joan is promoting the Texas Lions Club who are holding workshops for the border region to tackle mental health. Information sessions on "Mental health & Well Being in Rural Australia" and "Training the Presenter" which gives insight as to how to communicate with members of the community who are under mental stress. Gwydir Shire Council has also been running Men's Health Nights for the same purpose with success and there was unanimous discussion around the table in support of these events and in recognition of the seriousness of this issue throughout all communities within our shires.

Angus Witherby – Moree Plains Shire Council, Director of Planning & Community Development

In response to a previous recommendation from BROC, Angus presented on the various regional initiatives that are underway to take advantage of the Inland Rail Project. To date, the design plans for Narrabri to North Star are close to finalisation and the final route selection processes are underway for the North Star to Toowoomba section. There is an increased emphasis on the east – west transport links to optimise supply chains and value adding to make the most cost-effective use of the Inland Rail. This is for both processing of agricultural and primary industry products as well as developing fully traceable supply chains through the use of containerised product. With this as background, the NSW State Government has undertaken the Upper North West Regional Economic Development Strategy and has identified four major areas of priority:

- 1. Improve freight efficiency in agriculture and mining:
- 2. Encourage investment, increased productivity and value adding;
- 3. Invest in people, skills and community to address the skills gap; and
- 4. Diversify the economy through emerging industry sectors.

The take home message was that all BROC member Councils stand to benefit from the Inland Rail in some manner and his suggestion is that a combined approach from BROC to benefit from and optimise local economies to work with Inland Rail should be promoted. In effect BROC has the opportunity to act as a 'clearing house' so that all councils within the group can be aware of these regional developments. Road projects with a regional focus rather than a local one can significantly enhance transport flows and economic efficiencies. With this in mind, he provided details of the Moree Plains Shire Wide Transport and Intermodal Study and master plan which his Council has adopted. Finally, he will also be presenting this information to the Joint Organisations of Council to broaden the regional scope of preparing for Inland Rail in term of both proposed transport infrastructure and economic development.

Andy Norton - Vendor Panel

'Single Source Vendor Panel' is an organisation that provides a software solution for procurement for Local Government Councils. Mr Andy Norton presented this software system as a means of operational sourcing of regional buying and selling whilst providing transparency throughout the organisation. Vendor Panel has been well recognised in the industry with software awards and achievements because they allow for simple procurement, reduce the risk and maximise the potential for fair value. The system engages local operators and suppliers. It can run a tender or quote with personalised requirements & design and finalise it through the program. It utilises a

geometric system from your point of location which can be tailored to suit, i.e., 5km radius or 500km radius. It has an in-depth system of reporting and analysis and allows everything to be in one place, be efficient and collaborative, and to use best practice for good governance. Reported cost savings range from 10 – 30% due to economies of scale from the collaborative procurement. Interestingly, Balonne and Moree Shires use this software and gave it strong recommendation. I have given this information to Paul Pay (Manager Financial Services) and he is considering its potential for Inverell Shire Council.

General Business

The couple of items of note were from the water infrastructure conversation. Gwydir Shire Council stated that they have been in meetings with NSW Water and Namoi Irrigators over the potential development of dams at Gravesend and interestingly, with the cost being borne by users (i.e. irrigators) the appetite was tempered because of the economic return. Also, following the recent water debate that has been very active in the media, Balonne Shire provided some statistics regarding run off; NSW uses 55% of water run off while SA uses 54.5% of water run-off. The comments were that the MDBA plan should be allowed to run its course and for the extensively negotiated program of water management allowed to be implemented.

Joint Committee Bruxner Way

This committee was very grateful for the information provided by Justin Pay (Manager Civil Engineering), Inverell Shire Council showing the traffic count usage for the Bruxner Way. They asked if further detail could be extracted from these counter classifiers regarding single or multi-axle truck movements. They also asked when the information was taken and if seasonal factors were considered. Each Council is to come back with pinch points and other problem areas along the Bruxner Way for the purposes of a collaborative regional upgrade of the Bruxner Way.

RECOMMENDATION:

That:

- i) Inverell Shire Council continue to lobby for the removal of payroll tax and to support Bindaree Beef in their lobbying for the reduction of regulation in the beef industry;
- ii) Support the Texas Lions Club workshops on mental health within rural communities and promote via Council avenues;
- iii) Note the information from the North West Regional Economic Development Strategy and support BROC in being the organisation to coordinate regional freight networks in preparing for Inland Rail;
- iv) Investigate Vendor Panel and consider whether it might be relevant for Inverell Shire Council; and

SUMMARY:

The purpose of this report is to advise Councillors that the amendment to the *Inverell Local Environmental Plan 2012*, to permit water extraction and bottling facilities within the RU1 Primary Production zone, was gazetted on 8 February, 2019.

COMMENTARY:

In November 2017, Council commenced a Planning Proposal to amend the *Inverell Local Environmental Plan 2012* to permit water extraction and bottling facilities within the RU1 Primary Production zone. Following consultation with Government agencies and public exhibition, at the Ordinary Meeting of Council on 28 November, 2018, it was resolved (Res. 152/18):

INFORMATION REPORTS TO ORDINARY MEETING OF COUNCIL 27/02/2019

That:

- i) A request be made to Parliamentary Counsel to prepare the draft instrument pursuant to Section 3.36 of the Environmental Planning and Assessment Act 1979;
- ii) The General Manager be authorised to determine the terms of the draft instrument in consultation with Parliamentary Counsel, consistent with the intent of the Planning Proposal; and
- iii) The draft instrument be gazetted.

The request to draft the instrument was made to Parliamentary Counsel on 30 November, 2018.

On 31 January, 2019, Parliamentary Counsel determined that the amendment could be legally made and provided the drafted amendment for gazettal. The amendment was subsequently gazetted on 8 February, 2019, by way of on-line notification on the NSW Legislation website.

The amendment that was gazetted on 8 February, 2019, has been inserted as Section 6.8 into the *Inverell Local Environmental Plan 2012*, which states:

6.8 Water bottling facilities in Zone RU1 Primary Production

- (1) Despite any other provision of this Plan, development may be carried out with development consent for the purposes of a water bottling facility on land in Zone RU1 Primary Production if the consent authority is satisfied that the development will not have an adverse impact on natural water systems or the potential agricultural use of the land.
- (2) Despite any other provision of this Plan, development may be carried out with development consent for the construction of a pipe or similar structure on any land for the purposes of conveying groundwater to a water bottling facility.
- (3) In this clause:

water bottling facility means a building or place at which groundwater from land in Zone RU1 Primary Production is extracted, handled, treated, processed, stored or packed for commercial purposes.

The wording of the new Section 6.8 is consistent with the Planning Proposal undertaken by Council.
