Under section 4.18(1) of the EP&A Act, notice is given that the above development application has been determined by the granting of consent using the power in section 4.16(1)(a) of the EP&A Act, subject to the conditions specified in this notice.

Reasons for approval

- 1. The development, subject to conditions, is consistent with the objectives of the R1 General residential zone.
- ² The built form and design of the development, subject to conditions is consistent with the streetscape, development in the locality.
- 3 In consideration of the controls of the Inverell Development Control Plan 2013, the development is considered appropriate within the locality.
- 4 The use of the development as a "Single Dwelling" is conditioned as part of the development consent and considered consistent with the neighborhood character.

General Conditions

Compliance with Building Code of Australia and insurance requirements under Home Building Act 1989 1. It is a condition of a development consent for development that involves building work that the work must be carried out in accordance with the requirements of the Building Code of Australia. 2. It is a condition of a development consent for development that involves residential building work for which a contract of insurance is required under the Home Building Act 1989, Part 6 that a contract of insurance is in force before building work authorised to be carried out by the consent commences. 3. It is a condition of a development consent for a temporary structure used as an entertainment venue that the temporary structure must comply with Part B1 and NSW Part H102 in Volume 1 of the Building Code of Australia. 4. In subsection (1), a reference to the Building Code of Australia is a reference to the Building Code of Australia as in force on the day on which the application for the construction certificate was made. 5. Before issue of a construction certificate

10 Section 138

A separate application shall be made to Council for approval under Section 138 of the Roads Act 1993 to undertake any of the following:

- * Erect a structure or carry out a work in, on or over a public road; or
- * Dig up or disturb the surface of a public road; or
- Remove or interfere with a structure, work or tree on a public road; or
- Pump water into a public road from any land adjoining the road; or
- * Connect a road (whether public or private) to a classified road.

Condition reason: To ensure all necessary approvals under the Roads Act 1993 are obtained for the development.

Before building work commences

11 Construction - Erosion and Sediment Control

Prior to commencement of works (including earthworks), run-off and erosion control measures must be implemented to prevent soil erosion, water pollution and the discharge of loose sediment on the surrounding land. Measures are to include:

- * Diverting uncontaminated run-off around cleared or disturbed areas;
- * Erecting a silt fence and providing any other necessary sediment control measures that will prevent debris escaping into drainage systems, waterways or adjoining properties;

Preventing the tracking of segiment by vehicles onto roads; and * Stockpiling top soil, excavated materials, construction and landscaping supplies and debris within the lot. Run-off and erosion control measures must be in place for the duration of building work and until adequate (more than 70%) vegetation (grass) cover is established on the site to prevent debris escaping from the site into drainage systems, waterways, adjoining properties and roads. In the event that the building contract is completed, it is the responsibility of the owner to maintain the run-off and erosion control measures. Condition reason: To ensure sediment laden runoff and site debris do not impact local stormwater systems and waterways. 12 Sewer Junction Prior to the commencement of works on the site, a sewer junction application is to be submitted and approved by Councils and the new sewer junction installed in the approved location. Condition reason: To ensure that a new junction is installed to service the lot. Section 68 Approval Required 13 Prior to the installation of the relocatable home, approval under Section 68 of the Local Government Act 1993 is to be obtained for the installation of the home on Lot 16 DP 237554 Condition reason: To ensure that a Section 68 approval is obtained.

During building work

14	Hours of work
	Site work must only be carried out between the following times –
	From 7:00am to 5:00pm on Monday to Saturday
	Site work is not to be carried out outside of these times except where there is an emergency, or for urgent work directed by a police officer or a public authority.
	Condition reason: To protect the amenity of the surrounding area.
15	Construction - Local amenity, noise and environmental pollution
	To safeguard the local amenity, reduce noise nuisance and to prevent environmental pollution during the construction period:
	 Works on site are to be carried out in accordance with the Protection of the Environment Operations Act 1997 in relation to noise, dust and associated nuisances from the site. The carrying out of works shall not interfere with the quiet enjoyment of the surrounding neighbourhood;
	 Stockpiles of topsoil, sand, aggregate, spoil or other material shall be stored clear of any drainage path of easement, natural watercourse, footpath, kerb or road surface and shall implement measures to prevent the movement of such material off site:
	 Building operations such as brick cutting, washing tools, concreting and bricklaying shall be undertaken on the building block. The pollutants from these building operations shall be contained on site;
	 Builders waste must not be burnt or buried on site. All waste (including felled trees) must be contained and removed to a waste disposal depot;
	 Where the proposed development involves the disturbance of any existing survey monuments, those monuments affected will need to be relocated by a registered surveyor under the Surveying and Spatial Information Act 2002. A plan showing
	the relocated monuments will then be required to be lodged as a matter of public record at the Lands Titles Office.

	· all required inspections (including each applicable mandatory critical stage inspection) have been carried out; and
	any preconditions to the issue of the certificate required by a development consent have been met.
	Condition reason: To ensure an Occupation Certificate is obtained prior to use of the building.
17	Stormwater drainage
	Prior to issue of an Occupation Certificate, all stormwater (i.e. roof water and/or surface water) shall be drained in accordance with
	Australian Standard 3500.3 Plumbing and drainage.
	Condition reason: To ensure stormwater is disposed without causing a nuisance to adjoining properties
18	Compliance Plates
	Prior to occupation of the relocatable dwelling, compliance plate/s are to be attached to the dwelling which contain the following
	information:

- In ne name of the manufacturer of the manufactured nome of associated structure;
- * The unique identification number for each major section of the manufactured home;
- * The month and year during which the manufactured home or associated structure was constructed;
- * The design gust wind speed for the manufactured home or associated structure;
- * A statement that the manufactured home or associated structure complies with the Local Government (Manufactured Home Estates, Caravan Parks, Camping Grounds and Moveable Dwellings) Regulation 2021; and
- * The name of the practising structural engineer who issued the engineer's certificate for the manufactured home.

Condition reason: To ensure the development has the appropriate compliance plates attached to the manufactured home

19 Notification of Installation and Certification

Council must be given written notice of the installation of the manufactured home within 7 days after the completion of the installation. The notice must include:

- the site identifier of the dwelling site on which the relocatable home or associated structure has been installed; and
- * the particulars contained on each compliance plate relating to the relocatable home or associated structure.

The notice must also be accompanied by:

- a copy of the engineer's certificate for the relocatable home or associated structure;
- a fully dimensioned diagram of the dwelling site on which the relocatable home or associated structure is installed, sufficient to indicate whether or not the setback, density, open space and site delineation requirements of this Part have been complied with;
- a plumbing and drainage Certificate of Compliance;
- an electrical Compliance Certificate;
- a water proofing Compliance Certificate;
- a glazing Compliance Certificate; and
- * a termite protection Compliance Certificate.

Condition reason: To ensure Council is notified installation of the development has been finished and the required certification is supplied.

Occupation and ongoing use

20	Use of Dwelling
	The development is to be single dwelling use only and if the development is to be used for any other purpose eg: Group Home the
	prior Council consent is required.
	Condition reason: To ensure the use of the development is for a single dwelling only.

General advisory notes

This consent contains the conditions imposed by the consent authority which are to be complied with when carrying out the approved development. However, this consent is not an exhaustive list of all obligations which may relate to the carrying out of the development under the EP&A Act, EP&A Regulation and other legislation. Dictionary

The following terms have the following meanings for the purpose of this determination (except where the context clearly indicates otherwise):

Approved plans and documents means the plans and documents endorsed by the consent authority, a copy of which is included in this notice of determination.

AS means Australian Standard published by Standards Australia International Limited and means the current standard which applies at the time the consent is issued.

Building work means any physical activity involved in the erection of a building.

Certifier means a council or a person that is registered to carry out certification work under the Building and Development Certifiers Act 2018.

Construction certificate means a certificate to the effect that building work completed in accordance with specified plans and specifications or standards will comply with the requirements of the EP&A Regulation and *Environmental Planning and Assessment (Development Certification and Fire Safety) Regulation 2021.*

Council means INVERELL SHIRE COUNCIL.

Court means the Land and Environment Court of NSW.

EPA means the NSW Environment Protection Authority.

EP&A Act means the Environmental Planning and Assessment Act 1979.

EP&A Regulation means the Environmental Planning and Assessment Regulation 2021.

Independent Planning Commission means Independent Planning Commission of New South Wales constituted by section 2.7 of the EP&A Act.

Occupation certificate means a certificate that authorises the occupation and use of a new building or a change of building use for an existing building in accordance with this consent.

Principal certifier means the certifier appointed as the principal certifier for building work or subdivision work under section 6.6(1) or 6.12(1) of the EP&A Act respectively.

Site work means any work that is physically carried out on the land to which the development the subject of this development consent is to be carried out, including but not limited to building work, subdivision work, demolition work, clearing of vegetation or remediation work.

Stormwater drainage system means all works and facilities relating to:

- the collection of stormwater,
- the reuse of stormwater,
- the detention of stormwater,
- the controlled release of stormwater, and
- connections to easements and public stormwater systems.

Strata certificate means a certificate in the approved form issued under Part 4 of the Strata Schemes Development Act 2015 that authorises the registration of a strata plan, strata plan of subdivision or notice of conversion.

Sydney district or regional planning panel means Northern Regional Planning Panel.
