Terms and Reasons for Conditions

Under section 88(1)(c) of the EP&A Regulation, the consent authority must provide the terms of all conditions and reasons for imposing the conditions other than the conditions prescribed under section 4.17(11) of the EP&A Act. The terms of the conditions and reasons are set out below.

Condition reason: To ensure all parties are aware of the approved plans and supporting documentation that applies to the development.

6	Construction Certificate required prior to commencement of works on site
	No activity is to be carried out on site until a Construction Certificate has been issued, other than: <ul style="list-style-type: none"> • site investigation for the preparation of the construction; and/or • implementation of environmental protection measures, such as erosion control etc. that are required by this consent.
	Condition reason: To ensure no works commence until a Construction Certificate has been issued and any pre-construction conditions have been satisfied.
7	Zone of Influence
	All piers to be constructed to be 150mm below the zone of influence for Councils sewer main located through the allotment.
	Condition reason: To ensure that the footing for the development are located outside or below the zone of influence for the sewer main.
8	Landscaping Forward of Buildingline
	The decorative gravel shown forward of the building line is not to be used and instead be turf.
	Condition reason: To comply with Councils DCP.
9	Privacy Screens
	Privacy screens are to be installed on the side elevations closest to the side boundaries of the rear deck on each dwelling.
	Condition reason: To ensure the development does not impact the privacy of the adjoining lots.
10	Addressing of Units
	The units shall be numbered as follows: <ul style="list-style-type: none"> • 1/65 Mather Street, the unit located at the rear of the lot and • 2/65 Mather Street, the unit located at the front of the lot.
	Condition reason: To provide a street number for formal addressing of the units.

Measures are to include:</p> <ul style="list-style-type: none"> • Diverting uncontaminated run-off around cleared or disturbed areas; • Erecting a silt fence and providing any other necessary sediment control measures that will prevent debris escaping into drainage systems, waterways or adjoining properties; • Preventing the tracking of sediment by vehicles onto roads; and • Stockpiling top soil, excavated materials, construction and landscaping supplies and

	<p>debris within the lot.</p> <p>Run-off and erosion control measures must be in place for the duration of building work and until adequate (more than 70%) vegetation (grass) cover is established on the site to prevent debris escaping from the site into drainage systems, waterways, adjoining properties and roads. In the event that the building contract is completed, it is the responsibility of the owner to maintain the run-off and erosion control measures.</p> <p>Condition reason: To ensure sediment laden runoff and site debris do not impact local stormwater systems and waterways.</p>
15	<p>Sewer Junction</p> <p>Prior to the commencement of works on the site, a sewer junction application is to be submitted and approved by Council and the new sewer junction installed in the approved location.</p> <p>Condition reason: To ensure that a new junction is installed to service the lot.</p>
16	<p>Section 68 Approval Required</p> <p>Prior to the installation of the relocatable home, approval under Section 69 of the Local Government Act 1993 is to be obtained for the installation of the home on Lot 16 DP 237554.</p> <p>Condition reason: To ensure that a Section 68 approval is obtained.</p>

During building work

17	<p>Hours of work</p> <p>Site work must only be carried out between the following times –</p> <p>From 7:00am to 5:00pm on Monday to Saturday.</p> <p>Site work is not to be carried out outside of these times except where there is an emergency, or for urgent work directed by a police officer or a public authority.</p> <p>Condition reason: To protect the amenity of the surrounding area.</p>

	<p>Condition reason: To protect local amenity and survey monuments during construction.</p>
19	<p>Survey of Footings</p> <p>Prior to the commencement of works, the footings are to be setout by a registered surveyor and a report prepared and submitted to Council confirming the location of the footings in relation to the easement at the rear of the allotment.</p>
	<p>Condition reason: To ensure the footings of the development do not encroach on the easement.</p>

Before issue of an occupation certificate

21	<p>Stormwater drainage</p> <p>Prior to issue of an Occupation Certificate, all stormwater (i.e. roof water and/or surface water) shall be drained in accordance with <i>Australian Standard 3500.3 Plumbing and drainage</i>.</p>
	<p>Condition reason: To ensure stormwater is disposed without causing a nuisance to adjoining properties</p>
22	<p>Compliance Plates</p> <p>Prior to occupation of the relocatable dwelling, compliance plate/s are to be attached to the dwelling which contain the following information:</p> <ul style="list-style-type: none"> • The name of the manufacturer of the manufactured home or associated structure; • The unique identification number for each major section of the manufactured home; • The month and year during which the manufactured home or associated structure was constructed; • The design gust wind speed for the manufactured home or associated structure; • A statement that the manufactured home or associated structure complies with the Local Government (Manufactured Home Estates, Caravan Parks, Camping Grounds and Moveable Dwellings) Regulation 2021; and • The name of the practising structural engineer who issued the engineer's certificate for the manufactured home.
	<p>Condition reason: To ensure the development has the appropriate compliance plates attached to the manufactured home.</p>

Occupation and ongoing use

23	Use of Dwelling
	The development is to be single dwelling use only and if the development is to be used for any other purposes eg: Group Home then prior Council consent is required.
	Condition reason: To ensure use of the development is for single dwelling only.

General advisory notes

This consent contains the conditions imposed by the consent authority which are to be complied with when carrying out the approved development. However, this consent is not an exhaustive list of all obligations which may relate to the carrying out of the development under the EP&A Act, EP&A Regulation and other legislation. Some of these additional obligations are set out in the [Conditions of development consent: advisory notes](#). The consent should be read together with the *Conditions of development consent: advisory notes* to ensure the development is carried out lawfully.

The approved development must be carried out in accordance with the conditions of this consent. It is an offence under the EP&A Act to carry out development that is not in accordance with this consent. Building work or subdivision work must not be carried out until a construction certificate or subdivision works certificate, respectively, has been issued and a principal certifier has been appointed.

A document referred to in this consent is taken to be a reference to the version of that document which applies at the date the consent is issued, unless otherwise stated in the conditions of this consent.

Dictionary

The following terms have the following meanings for the purpose of this determination (except where the context clearly indicates otherwise):

Approved plans and documents means the plans and documents endorsed by the consent authority, a copy of which is included in this notice of determination.

AS means Australian Standard published by Standards Australia International Limited and means the current standard which applies at the time the consent is issued.

Building work means any physical activity involved in the erection of a building.

Certifier means a council or a person that is registered to carry out certification work under the *Building and Development Certifiers Act 2018*.

Construction certificate means a certificate to the effect that building work completed in accordance with specified plans and specifications or standards will comply with the requirements of the EP&A Regulation and *Environmental Planning and Assessment (Development Certification and Fire Safety) Regulation 2021*.

Council means INVERELL SHIRE COUNCIL.

Court means the Land and Environment Court of NSW.

EPA means the NSW Environment Protection Authority.

EP&A Act means the *Environmental Planning and Assessment Act 1979*.

EP&A Regulation means the *Environmental Planning and Assessment Regulation 2021*.

Independent Planning Commission means Independent Planning Commission of New South Wales constituted by section 2.7 of the EP&A Act.

Occupation certificate means a certificate that authorises the occupation and use of a new building or a change of building use for an existing building in accordance with this consent.

Principal certifier means the certifier appointed as the principal certifier for building work or subdivision work under section 6.6(1) or 6.12(1) of the EP&A Act respectively.

Site work means any work that is physically carried out on the land to which the development the subject of this development consent is to be carried out, including but not limited to building work, subdivision work, demolition work, clearing of vegetation or remediation work.

Stormwater drainage system means all works and facilities relating to:

- the collection of stormwater,
- the reuse of stormwater,
- the detention of stormwater,
- the controlled release of stormwater, and
- connections to easements and public stormwater systems.

Strata certificate means a certificate in the approved form issued under Part 4 of the *Strata Schemes Development Act 2015* that authorises the registration of a strata plan, strata plan of subdivision or notice of conversion.

Sydney district or regional planning panel means Northern Regional Planning Panel.
